SPECIAL NOTE: It is specifically stated on the bid that vendors are **NOT** to furnish inferior “gray market” film and supplies (products produced for Kodak or Polaroid in other countries and sold here). Please check cartons and boxes closely for acceptable expiration dates and for any marking that would indicate product was produced in a foreign country. Please notify this office **at once** if products received appear “suspicious” in any way.
